GUIDELINES & ENTRY RULES

- Entries should be capable of withstanding 40 mph winds.
- All bases must be capable of supporting the scarecrow in a free standing/staked manner - must be capable of fitting on a wooden post for display.
- The Park reserves the right to remove any scarecrow that deteriorates to an unacceptable level during the month. Please make your submissions as weather-proof and indestructible as possible durability is a must!
- The Park will provide signage identifying your organization and the name of your scarecrow. The Great Park will determine the location of all scarecrows. Please do not include any signage or flyers with your scarecrow.
- Participants are encouaged to assist our volunteers in the installation of their scrarecrows.
- Maximum overall dimensions must not exceed 7' x 7' x 7' without prior permission.
- Please do not include live plant material or mulch with your display.
- Please do not use any battery or electrically operated materials.
- The Park reserves the right to use photographs, contact names, and scarecrow names for publicity purposes.
- Entries must be suitable for viewing by small children. Entries
 reflecting controversial political or social subject matter, in poor
 taste for family viewing (e.g. very scary/gory), in nature will not
 be accepted.
- Scarecrows must not exceed 35 lbs. in weight.
- All voting and judging is final.
- Please do not include food on your display.
